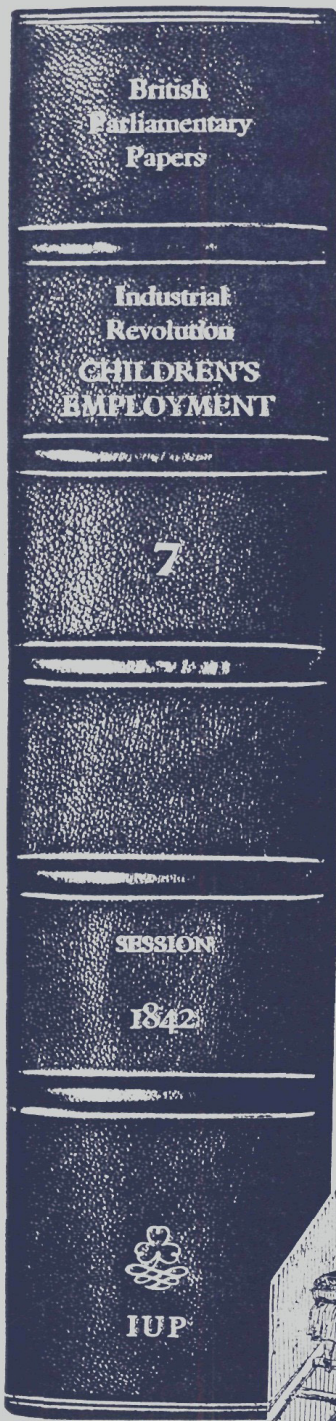

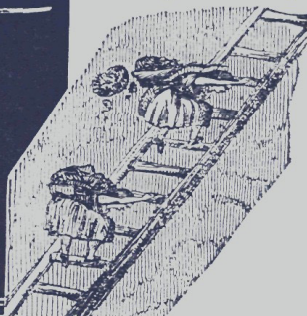

This new, two-color edition appears at a time when American government is experiencing profound stresses and challenges domestically and abroad. No principle or practice of American government is any longer taken for granted. For this reason, the authors have devoted the first section of their book to a probing analysis of democracy. A new Chapter I, "Conceptions of Democracy," is a comparative study of democracy as a system of power, with particular emphasis on its meaning to Western, Communist, and developing nations. The second chapter, also new, deals with "Conflict Resolution in the Political Process." To illustrate the new challenges of a "conflict perspective," the chapter examines the functions of conflict and its resolution—peaceful or violent—in the American political experience. Finally, the first section considers the challenges to democracy of authoritarianism and totalitarianism at home and abroad. Throughout the book, the American scene is illuminated by appropriate comparisons to other democratic and nondemocratic systems. Basic theory is stressed, with due consideration given to pertinent historical information, institutional operations, and empirical political behavior.

The new edition is strongly oriented toward critical and controversial issues that now dominate American government and politics. There is particularly extensive discussion of political participation, parties, and interest groups, violence and confrontation politics, government and the economy, civil rights, Black Power, pornography and the courts, the changing roles of Congress and the Presidency, and the welfare crisis. In dealing with these highly relevant and often explosive issues the authors express their views, not to lay down certainties but to stimulate thought and classroom discussion.

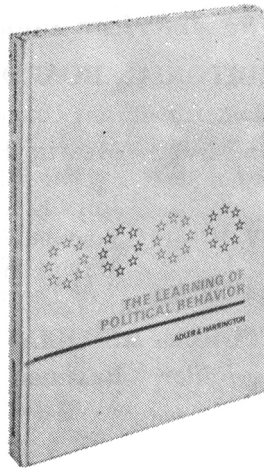

THE LEARNING OF POLITICAL BEHAVIOR

The Learning of Political Behavior is the only book that makes the findings of the rapidly growing field of political socialization available to educators and non-professionals as well as professionals in their original form. The book begins with an excellent introduction by Adler and Harrington explaining the book, its field, and discussing the key concepts of politics and socialization. Next follows literature from the field with articles drawn from a variety of journals and other original sources. The literature in Part Two deals with politics in childhood and features articles by Robert Seigel, David Easton and Robert Hess, Edwin D. Lawson, Dean Jaros, Fred I. Greenstein, and Robert O'Neil to name only a few. In Part Three, which treats the family, school, and peer effects, a representative sampling of distinguished contributors includes James C. Davies, Judith V. Torney, Kenneth P. Langton, and Edgar Litt. A concluding essay by the authors points up future areas of research and discusses educational issues.

The only reader in the field of political socialization, *The Learning of Political Behavior* is a valuable supplement for social studies curriculum courses and political science courses in political socialization, government, and education.
