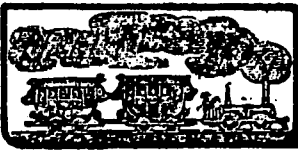
Lloyd G. Reynolds

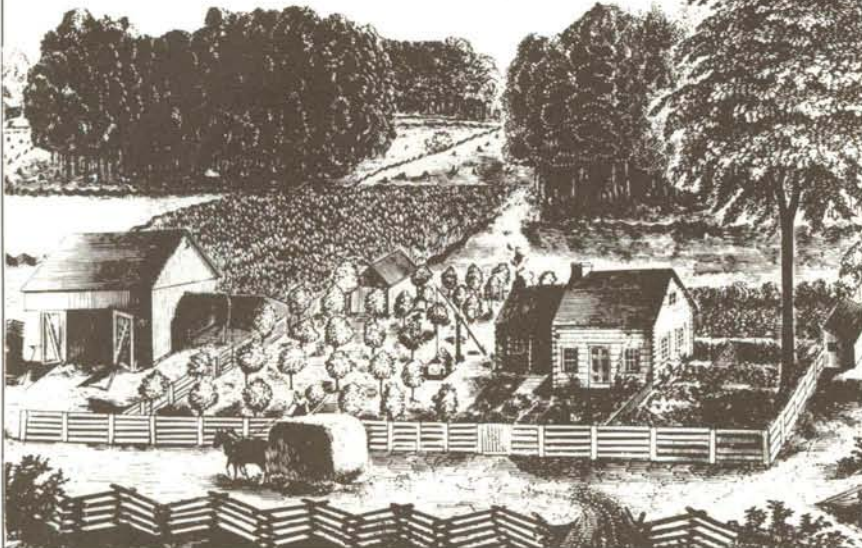
