Constitutional Theory

Geoffrey Marshall, *Fellow of The Queen's College, Oxford*

This book introduces and examines some of the basic ideas underlying the Anglo-American system of constitutional government—the State, Law and Convention, Sovereignty, the Separation of Powers, Judicial Review, Equality, Liberty, and Public Order. Two styles of constitutionalism are contrasted. In the second part of the book the major civil rights are considered—in particular the right to equality before the Law and the right to freedom of speech and assembly. An Introduction to the Law of Contract

P. S. Atiyah, *Faculty of Law, The Australian National University*

This book gives students an overall view of the subject, either at the commencement of their studies or in conjunction with established textbooks. The new edition has been extensively revised, gives greater emphasis to current trends, and brings out more clearly the commercial and social policy issues which underlie contract law. It also illustrates the way in which lawyers give effect to these policy considerations through the skilful development of legal concepts. This has involved some digressions into the nature of legal reasoning, and the author attempts to apply some of the lessons which lawyers have learned from legal philosophers. Administrative Law

H. W. R. Wade, *Professor of English Law, University of Oxford*

The powers of the state are growing incessantly and they affect every citizen in numerous ways. Full account is taken of recent decisions in which the courts have asserted their powers. This book attempts to clarify the framework of a subject which has been insufficiently recognized as a single body of law.
