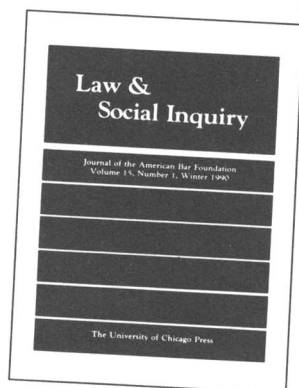

Even more than the well-known images of the lone gunfighter or the reckless cowboy, the penitentiary was an important symbol of violence in the American West, violence that intensified when compounded by the factors of race, class, or sex.

She explores how nineteenth-century criminologists constructed the "criminal woman," the elements of age, race, class, and gender in women's court proceedings, the kinds of violence encountered by women inmates, their diet, illnesses, experiences with pregnancy and child-bearing, prison work systems for women, and women's own strategies for response.

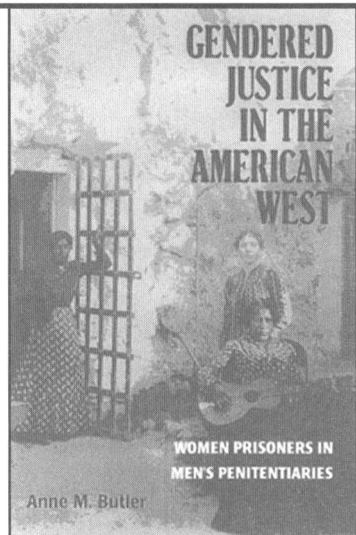

Purifying America

*Women, Cultural Reform,
and Pro-Censorship
Activism, 1873-1933*

Purifying America explores the widespread middle-class advocacy of censorship as a popular reform around the turn

of the century and provides a historical perspective on contemporary debates over censorship, morality, and pornography that continue to divide women.

In contrast to elite, male, anti-obscenity crusaders, organizations as diverse as the reformist Woman's Christian Temperance Union and the American Library Association worked to curtail immorality in both "high" and "low" culture, including literature, newspapers, art, radio, and film. However, the two groups advocated different approaches to solving the problem. The WCTU promoted censorship laws while at the same time producing alternative "pure" forms of popular culture. Librarians generally rejected government censorship, preferring to control materials going into and out of the library.

These woman cultural reformers were not simply proponents of an old-fashioned moral code. Rather, they employed new medias and technologies to create their own cultural materials and wielded professional expertise in pursuit of greater control over new educational resources for children.

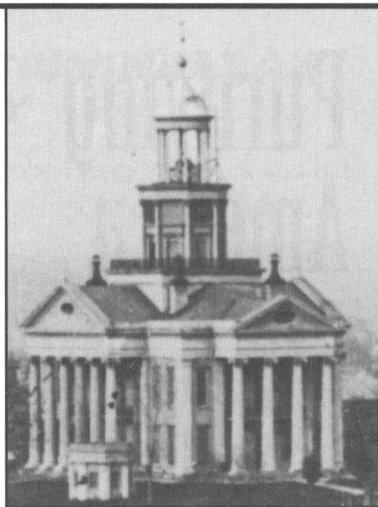
In Vicksburg, Mississippi, white exploitation of black labor through slavery evolved into efforts to use the law to define blacks' place in society, setting the stage for widespread tolerance of brutal vigilantism. Fed by racism and economics, whites' extralegal violence grew in a hothouse of more general hostility toward law and the courts. *Roots of Disorder* shows how the criminal justice system itself plays a role in shaping the attitudes that encourage vigilantism.
