JEREMY ADELMAN was educated at the University of Toronto and the London School of Economics (1985) and completed a doctorate in modern history at Oxford University (1989). He is the author or editor of ten books, including *Worldly Philosopher: The Odyssey of Albert O. Hirschman* (2013). He has received fellowships from the British Council, the Social Science and Humanities Research Council of Canada, and the Guggenheim Memorial Foundation, as well as the American Council of Learned Societies Frederick Burkhardt Fellowship. Currently he is Henry Charles Lea Professor of History and director of the Global History Lab at Princeton University.

DANILO ANTONIO CONTRERAS is a postdoctoral teaching fellow in the Center for Interdisciplinary Studies at the College of the Holy Cross. His research examines the effects of institutional and structural constraints on ethnoracial politics in Afro-Latin America. He received his PhD from the Department of Government at the University of Texas at Austin.

She studies the conflicting attitudes toward the recent democratic transition in Chile, Mexico, and Peru in cinematic adaptations of recent and classic fiction. From 2006 to 2014, she was director of the David Rockefeller Center for Latin American Studies at Harvard University. She is a specialist on the comparative analysis of policy making, implementation, and public management in developing countries, with particular reference to Latin America. Her most recent book is *Jobs for the Boys: Patronage and the State in Comparative Perspective* (Harvard University Press, 2012). A political scientist with a PhD from MIT, Grindle is currently engaged in research on Harvard's early travelers to Latin America.

GRACIELA MAMANI-VARGAS studied psycho-pedagogy at the Universidad Pública de El Alto (UPEA). She currently works for the Fundación "Jacha Uru" in the Department of La Paz, Bolivia, working alongside families of children in a situation of disability.

LAURA NUZZI O'SHAUGHNESSY is emerita Charles A. Dana Professor of Government at St. Lawrence University, where she taught for many years. O'Shaughnessy is the coauthor of *Nicaragua's Other Revolution: Religious Faith and Political Struggle* (with Michael Dodson, 1990), which was selected as a Choice Outstanding Academic Book, and *The Church and Revolution in Nicaragua* (with Luis Serra, 1986), as well as numerous book chapters and articles in scholarly journals such as *Human Rights Review*, *Journal of Latin American Studies*, *Bulletin of Latin American Research*, *International Journal of Human Rights*, *Estudios Centroamericanos*, *Relaciones Interamericanas*, and *Christianity and Crisis*. Rev. O'Shaughnessy completed a master's of divinity from Colgate Rochester Crozer Divinity School and was ordained to the ministry as pastor and teacher in 2012. Currently, she works in the Berkshire Association of the Massachusetts Conference of the United Church of Christ.

DUSAN PAREDES es doctor en economía aplicada por la Universidad de Illinois (EEUU). Actualmente es profesor del Departamento de Economía de la Universidad Católica del Norte (Antofagasta, Chile). Simultáneamente, es profesor asociado a la Universidad de Illinois y a la Universidad de Oviedo. Desde el 2010, es director ejecutivo de la Sociedad Chilena de Estudios Regional (SOCHER). Sus áreas de investigación están centradas en entender la naturaleza de las disparidades espaciales entre los mercados de trabajo y vivienda regionales.

MARCY SCHWARTZ is associate professor of Latin American literature and culture, and an affiliate of the Center for Latin American Studies at Rutgers University, New Brunswick. Her research focuses on urban space and public policy in relation to contemporary Latin American literature and photography. She is the author of *Writing Paris: Urban Topographies of Desire in Contemporary Latin American Fiction* (1999) and *Invenções urbanas: Ficção y ciudad latinoamericanas* (2010), and coeditor of *Voice-Overs: Translation and Latin American Literature* (with Daniel Balderston, 2002) and *Photography and Writing in Latin America: Double Exposures* (with Mary Beth Tierney-Tello, 2006). Currently she is working on a book on public reading programs in Latin American cities, supported by research fellowships from the American Council of Learned Societies (2014–2015) and the National Endowment for the Humanities (2015–2016).

RANDAL SHEPPARD is a postdoctoral researcher at the Institute for Iberian and Latin American History, University of Cologne, Germany. He is currently working on the European Research Council project “Left-Wing Exile in Mexico, 1934–1960,” researching the relationship among modern design, politics, and exile in Mexico, Cuba, and the United States. His forthcoming book discusses the politics of history and nationalism in the context of social, political, and economic developments in Mexico since 1968.

NADIA ZYSMAN is currently a postdoctoral fellow in the International Research Training Group “Between Spaces” at the Institute for Latin American Studies, Freie Universität Berlin.
