In March 1971 the Board of Directors of the African Studies Association decided to expand the Association's publications to include a quarterly journal of opinion. In full cognizance of the number and scope of existing periodicals on Africa, the Board felt that the ASA, an organization created to facilitate communication among Africanists, could help promote public awareness of issues presently confronting scholars and policy-makers by means of a journal, or forum, for the exchange of different points of view.

At its inaugural meeting, the Committee on Current Issues of the African Studies Association proposed that members and potential members of the ASA be advised of the urgent need for continuing research into subjects involving the racial, colonial, and neo-colonial domination of African peoples with particular reference to the role and responsibilities of the United States and American interests. In conformity with this proposal, the African Studies Association presents *ISSUE*. The journal will publish findings of the Committee on Current Issues and will furnish a medium for the statement of opinion on Africa and African studies by individual members.
