Wide et al. have indicated that Table Va (p 90) in their article is incorrect because the odds ratios and confidence intervals are based on those for a matched case-control study, whereas the data for the subjects and control infants are for an unmatched case-control study. The correct Table Va is given below.

Complete protocols on minor anomalies were obtained from 83 complete pairs out of the 87 matched subject/control infant pairs born to mothers participating once or for the first time in the study. Odds ratio (OR) and the 95% confidence intervals (CI) were calculated as conditional logistic regression analyses.
