The Council of Europe was founded by ten nations on 5 May 1949, as the first European political institution, with the first international parliament; at 15 July 1995 it is, with thirty-six member countries, the European organisation with the widest geographical representation.

The Council was set up to "achieve a greater unity between its members for the purpose of safeguarding and realising the ideals and principles which are their common heritage and facilitating their economic and social progress". It is to achieve this aim "by discussion of questions of common concern and by agreements and common action in economic, social, cultural, scientific, legal and administrative matters and in the maintenance and further realisation of human rights and fundamental freedoms" (Article 1 of the Statute). Only the military aspects of defence are outside of its competence.




