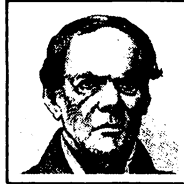

The Journal of Eduard Harkort, 1832–1834

The journal of Eduard Harkort, written during his two years of fighting and imprisonment in Mexico, reveals the feelings and activities of a brave man who withdrew from nineteenth-century corporate life to join the ragtag rebel army of Gen. Santa Anna. Harkort ultimately found himself in battle, before a firing squad, and in prison. First published in 1858 by Harkort's son-in-law, the journal has now been translated from German and annotated by Louis E. Brister.
