ALBERT S. BACDAYAN obtained his Ph.D. from Cornell University in 1967 and is currently Assistant Professor of Anthropology at the University of Kentucky. His research interests are in legal and political anthropology and in cross-cultural comparisons. He has done fieldwork on the legal acculturation of the Kalinga Igorots in the Philippines and is currently engaged in archival research on the history of modern government control, particularly during the American era, in the northern Luzon mountain region. His previous publications are: a crosscultural study with Frank W. Young, "Menstrual Taboos and Social Rigidity," *Ethnology*, April 1965; and "Religious Conversion and Social Integration in a Western Bontoc Village Complex," *St. Louis Quarterly*, March 1967.

LAWRENCE M. FRIEDMAN is Professor of Law at Stanford University.
