KANT: A STUDY

by GABRIELLE RABEL. This book attempts to reproduce Kant's essential thought in easily readable language, avoiding verbosity and repetition, and to reveal as much as possible of his tone, the 'human touch,' and occasional wit of his writings. It includes sixty-three items, taken from all his publications, among which are some short papers of general interest published here for the first time in English. (\$11.50)

THE LATER PHILOSOPHY OF R. G. COLLINGWOOD

by ALAN DONAGAN. This is a critical study of Collingwood's philosophical work from 1933 to his death in 1943. After 1930, although developing, Collingwood's philosophy of art, of natural science, of psychology, and of history remained fundamentally the same. His conception of philosophy, on the other hand, changed bewilderingly, from the idealism of the *Essay on Philosophical Method* (1933) to the historicism of the *Autobiography* (1939) and *Essay on Metaphysics* (1940). The author offers a controversial explanation of why Collingwood abandoned his earlier position. (\$7.75)

SIMONE WEIL: SELECTED ESSAYS 1934-1943

Two important collections of Simone Weil's writings have not appeared in English, and from these, thirteen essays have been selected and translated for this volume by Sir Richard Rees. Their themes are philosophical, historical and political. (\$6.75)

by JOHN BAILLIE. This volume contains twelve addresses given on a variety of occasions by the renowned scholar and Christian leader, and a memoir on John Baillie in his private as well as public life. (clothbound \$3.50—paperbound \$1.35)

STUDIES IN SELF-INTEREST FROM DESCARTES TO LA BRUYERE

by A. J. KRAILSHEIMER. These studies trace the common preoccupation of eight French writers of the seventeenth century—Descartes, Corneille, Retz, La Rochefoucauld, Pascal, Molière, Bossuet, and La Bruyère—with the problem of the individual and their different attempts to overcome the disruptive legacy of the sixteenth century. The author's thesis is that the individual was unable to stand the strain imposed by a century obsessed with self. (\$5.50)
