The Bear and His Sons Masculinity in Spanish and Mexican Folktales

All the world over, people tell stories to express their deepest feelings. Often groups of people widely separated by space or time will tell the same basic story, but with differences in the details that reveal much about a particular group's worldview. In this book, Taggart contrasts how two men—a Spaniard and an Aztec-speaking Mexican—tell such tales as “The Bear’s Son.” He explores how their stories present different ways of being a man in their respective cultures. In particular, he shows how fathers who care for their infant sons teach them a relational masculinity based on a connected view of human relationships.

From Viracocha to the Virgin of Copacabana By Verónica Salles-Reese

In this study, Salles-Reese explores how Andean myths of cosmic and ethnic origins centered on Lake Titicaca evolved from pre-Inca times to the enthronement of the Virgin of Copacabana in 1583. She begins by describing the myths of the Kolla (pre-Inca) people and shows how their Inca conquerors attempted to establish legitimacy by reconciling their myths of cosmic and ethnic origin with the Kolla myths. She also shows how a similar pattern occurred when the Inca were conquered in turn by the Spanish. This research explains why Lake Titicaca continues to occupy a central place in Andean thought despite the major cultural disruptions that have characterized the region's history.

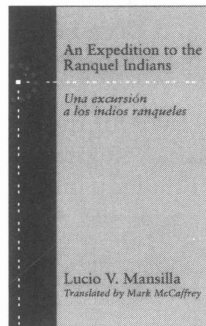
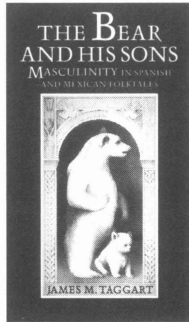

In this compelling ethnography, Carlsen explores the issue of cultural continuity and change as it has unfolded in a representative Mayan community. Drawing on documentary evidence, he argues that local Mayan culture survived the Spanish Conquest remarkably intact and continues to play a defining role in the religious and social life of the community. At the same time, however, he shows how the twentieth-century consolidation of the Guatemalan state has steadily eroded the capacity of Mayan communities to adapt to change and has caused some local factions to reject—even demonize—their own culture. Carlsen offers a rare insider's perspective and fifteen years of field research in Atilán, where he learned Tz'utujil, was accepted into a local *cofradía*, and was a

first-hand witness to *la violencia*.
