### Awards

The winner of the 1991 Merck award in Scotland was Dr Allan Scott, a Lecturer in the Department of Psychiatry, Edinburgh University, and now Consultant Psychiatrist at the Royal Edinburgh Hospital. The award will enable him to visit the Karolinska Institute, Stockholm, to gain experience in the general principles of quantitative in vivo specific ligand/receptor binding techniques in man using SPET which he hopes to apply to further studies in ECT. On his return he will present a paper at a quarterly meeting of the Scottish Division of the Royal College of Psychiatrists.

The Merck award(s) (total annual value £1,500), to be made by the Scottish Division, are open to members of the College working in Scotland who are trainee psychiatrists or are consultants within three years of their first appointment. The award(s) may take the form of a research or travelling grant.

Applicants should submit a curriculum vitae, a statement of current interests and planned research or study, and the names of two referees before 30 September 1992 to Dr I. M. Pullen, Secretary, Scottish Division (Royal College of Psychiatrists), Royal Edinburgh Hospital, Edinburgh EH10 5HF.

The 1993 IPA Research Awards in Psychogeriatrics, sponsored by Bayer AG, will be presented at the Sixth Congress of the International Psychogeriatric Association to be held from 5–10 September 1993 in Berlin. Only unpublished results of original research in psychogeriatrics will be considered. Submission deadline: 1 December 1992.
