
Additional Transnational Initiatives:

With over a century of tradition and experience behind it, ASIL's Annual Meeting has become the most important gathering in the field of international law.

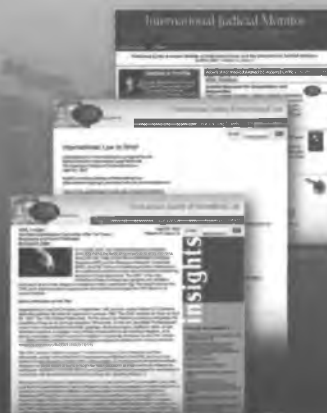
More than 1,000 practitioners, academics, and students travel to Washington, DC, each spring from all over the world to debate and discuss the latest developments in their field.
