### A UNIQUE PROGRAM

The Hopkins-Nanjing Center offers a one-year residential graduate-level program in China for 50 Chinese and 50 "international" (American and other English-speaking) students and professionals. International participants are selected competitively from universities in the United States and around the world by Johns Hopkins University. Although the majority of these students are American, up to a quarter can be citizens of other countries who can show proficiency in English. Citizens of the PRC, Hong Kong and Taiwan who wish to apply should contact the Center in Nanjing directly. A non-degree program, the Center is most valuable as an enhancement to other kinds of advanced training and professional development.

### THE CURRICULUM

Courses for international students focus on China's history, foreign relations, government, politics, society, economics, trade, and language. Since all courses are taught in Mandarin by Chinese professors and all reading assignments, exams and research papers are completed in Chinese, a language proficiency test is required of all applicants. Courses for Chinese students are taught in English and cover topics related to the United States and the international system. In addition, the Center hosts seminars, conferences and lectures on business, law, political science, history and culture.

### THE CENTER

The Center is located on the campus of Nanjing University and offers students the chance to study contemporary China—its society, economy, history, and political system—from a Chinese perspective. While language training is available, the Center's primary purpose is to train advanced students in China studies. The residential nature of the program enhances language skills through social contact with Chinese classmates, roommates and faculty.

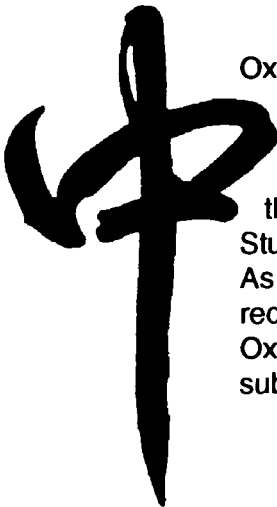

### *Manuscripts*

*The China Quarterly* welcomes the submission of manuscripts from scholars, including postgraduate students, on all aspects of contemporary China and from all points of view, including those which deal with Taiwan and Overseas Chinese. Articles on China prior to 1949 are also welcome, particularly, but not exclusively, when these relate directly to contemporary China or to the history of the Chinese Communist Party. Articles should be submitted, in quadruplicate to the editorial office. They should normally not exceed 8,000 words in length; should be typed in double spacing, with footnotes at the end; and should conform to the styling of *The China Quarterly* (see below). Submission of a manuscript is taken to imply that it has not previously been published in any form (including non-copyrighted working papers) and that it is not currently being considered elsewhere.

*The China Quarterly* is published by the School of Oriental and African Studies, University of London. The views expressed in articles are those of individual authors and do not necessarily represent the views of the School.

#### *Romanization*

*Pinyin* is used without tone/diacritical marks, except the following which should use the Wade-Giles system; names such as Chiang Kai-shek, Sun Yat-sen, Taipei and Kuomintang; names of individuals living outside mainland China. Chinese characters should be provided on the first occurrence of each romanization, to assist in proofreading.
