Maoz Brown is a PhD candidate in sociology at the University of Chicago with research interests relating to the intersection of nonprofit organizational behavior and public policy, past and present. Maoz was recently a doctoral fellow at University of Pennsylvania's Center for Social Impact Strategy and an Elmer L. Andersen Research Scholar at the University of Minnesota's Social Welfare History Archives.

Yasemin Dildar is assistant professor of economics at California State University San Bernardino. She is a development economist and feminist economist. Her dissertation studied the determinants of labor force participation in Turkey, a chapter of which was published recently in the journal *World Development*. She is working on the determinants of domestic violence in Turkey.

Marc Di Tommasi is a teaching and research assistant at the University of Edinburgh. His research focuses on the history of migration to Scotland before World War I. Instead of focusing on just one migrant group he researches all the migrants present in one area comparing them with the local population to better capture general trends and get a sense of their lived experiences. The main sources of this research are quantitative numerical sources like census records and bank accounts. Using this data and with the help of GIS software he has been developing a series of thematic maps on migration.

Michael Hechter is Foundation Professor in the School of Politics and Global Studies at Arizona State University and professor of sociology at the University of Copenhagen. A fellow of the American Academy of Arts and Sciences, he studies contentious collective action—principally in its nationalist and separatist forms—and its converse, social order. His most recent book is *Alien Rule* (2013), which argues that this widely denigrated form of governance may, under certain conditions, attain legitimacy.

Alexander Horn is an assistant professor in the Department of Political Science at Aarhus University, Denmark. His work has appeared in the *European Journal of Political Research* and the *Journal of European Social Policy*. His forthcoming book, *Government Ideology, Economic Pressure and Risk Privatization: How Economic Worldviews Shape Social Policy Choices in Times of Crisis*, will be published by Amsterdam University Press in 2017 in the series *Changing Welfare States*.

Britta L. Jewell completed her PhD in infectious disease epidemiology from Imperial College, London, following an MSc in the history of science, medicine, and technology from Oxford University. She has also holds a BA degree in European history, with highest honors, from the University of California, Berkeley. Currently, she is a postdoctoral scholar at the University of California, Berkeley, where her research focuses on mathematical modeling of issues associated with HIV prevention.

Nicholas P. Jewell is professor of biostatistics and statistics at the University of California, Berkeley. He was formerly vice provost for the Berkeley campus from 1994 to 2000. He is a statistician with longtime interests in infectious diseases and human rights. He and his co-authors have previously published a chapter regarding casualty counting in an Oxford University Press volume, *Counting Civilian Casualties: An Introduction to Recording and Estimating Nonmilitary Deaths in Conflict* (2013), edited by Seybolt, Aronson, and Fischhoff.

Anthony Keivins is an assistant professor in the Department of Political Science at Aarhus University, Denmark. His recent book, *Expanding Welfare in an Age of Austerity: Increasing Protection in an Unprotected World* (2017), is available from Amsterdam University Press. His work has also appeared in the *Journal of European Social Policy*, the *European Political Science Review*, and the *Canadian Journal of Political Science*.

Daniel MacDonald is assistant professor of economics at California State University San Bernardino. He is an economic historian and labor economist who has published articles on nineteenth-century US economic history and labor economics. He is working on a project that explores the connection between property rights and economic growth in US history.

Dr. Jennifer M. Nations studies the policy-making process, specifically how the structure of institutions, cultural beliefs, and social inequalities shape policy outcomes. She is currently a Postdoctoral Fellow on the Democracy Project at University of California, San Diego's Department of Sociology.

Steven Pfaff is professor of sociology at the University of Washington. He conducts research in the fields of historical and comparative sociology, collective action and social movements, political sociology, and the sociology of religion. His book *Exit-Voice Dynamics and the Collapse of East Germany* (2006) was honored by the Social Science History Association and the European Academy of Sociology.

Adam Silver is assistant professor of political science at Emmanuel College. He specializes in American political development, political parties and organizations, campaign strategies, and electoral politics. He is a co-editor of *Agitation with a Smile: Howard Zinn's Legacies and the Future of Activism* (2013).

Michael Spagat is professor of economics at Royal Holloway College, University of London. He gained his PhD at Harvard University and earlier held faculty posts at Brown University and the University of Illinois. Spagat's published papers on armed conflict have been published in *Nature*, the *New England Journal of Medicine*, the *Journal of Peace Research*, the *Journal of Conflict Resolution*, and *PLoS Medicine*. His current research addresses universal patterns in modern war, the Dirty War Index civilian casualties in the Iraq conflict, and problems in the measurement of war deaths.

Patrick Underwood is a data analyst at JP Morgan Chase. His areas of specialization are data analysis, quantitative research methods, comparative/historical sociology, and political sociology. His dissertation project examined the effect of strategic implementation of neoliberal economic reforms on the risk of collective political unrest in urban populations. His co-authored papers have appeared in the *American Sociological Review* and the *British Journal of Political Science*.

Jael Goldsmith Weil is a professor at the Universidad Central de Chile. She completed her PhD training at Northwestern University in 2014 and her master's degree in public policy from the LBJ School of Public Policy at the University of Texas at Austin in 2003. Her areas of specialization are comparative politics, social policy, research methods, and food politics. She has published articles in *Bulletin of Latin American Research* and *Revista Historia*.
