John Brigham is Professor of Political Science at the University of Massachusetts, Amherst. He is the author of *The Cult of the Court* and *Property and the Politics of Entitlement*. His forthcoming book, *Law's Politics*, looks at law as an independent variable in movement politics. He has served as a Trustee of the Law and Society Association.

Lauren B. Edelman is Associate Professor of Sociology and Law at the University of Wisconsin–Madison. She has published articles on organizational response to civil rights law and the role of professions in shaping organizational response to law. Her current research focuses on the internal legal culture of organizations, the role of law in shaping employers' conceptions of efficiency, and its role in extralegal dispute processing.

Howard S. Erlanger is Professor of Sociology and Voss-Bascom Professor of Law at the University Wisconsin–Madison. His current sociological work deals with lawyers' careers and with implementation of law in the organizational context. Since 1982 he has been editor of the Review Section of *Law and Social Inquiry*.

John O. Haley is Garvey Schubert and Barer Professor of Law and Professor of International Studies at the University of Washington, where he has taught Japanese law since 1974. He has spent more than six years in Japan, beginning in 1964 as a teaching assistant at the International Christian University in Tokyo; he was a Senior Fulbright Research Scholar at Kyoto University (1971–72), with the law firm of Blakemore & Mitsuki (1972–74), a Visiting Professor of Law, Kobe University (1984), and Fulbright Lecturer at Tohoku University (1992–93). He has written many articles on Japanese law and for more than a decade was editor-in-chief of *Law in Japan: An Annual*. In addition to his *Authority without Power* (reviewed here), he is co-author with John Henry Merryman and David S. Clark of the forthcoming *The Civil Law Tradition: Europe, Latin American and East Asia* (Michie). He is currently working on a book entitled *The Spirit of Japanese Law* (University of Georgia Press).

David T. Johnson is a Ph.D. candidate in the Jurisprudence and Social Policy Program at the University of California at Berkeley Boalt Hall School of Law. He is currently a Fulbright Research

Scholar at Kobe University in Japan, where he is conducting research on Japan's prosecutors.

Mark Kessler is Associate Professor of Political Science at Bates College. He is author of *Legal Services for the Poor: A Comparative and Contemporary Analysis of Interorganizational Politics* (1987) and articles on law and social change, legal mobilization, legal culture, and organizational decisionmaking. He is currently engaged in research on legal ideology and is co-authoring a text for St. Martin's Press on the role of historically marginalized groups in American politics.

Herbert M. Kritzer is Glenn B. and Cleone Orr Hawkins Professor of Political Science and Professor of Law at the University of Wisconsin–Madison. He is the author of *The Justice Broker* (Oxford University Press, 1990) and *Let's Make a Deal* (University of Wisconsin Press, 1991). In addition to empirical studies of civil procedure, his current research activities include alternative forms of representation and advocacy and comparative analyses of propensity to sue.

John Lande previously practiced law and mediation and is now a Hewlett Legal Studies Fellow and doctoral student in sociology at the University of Wisconsin–Madison. His dissertation research addresses the diffusion of ideologies about dispute resolution within the legal profession.

Raymond Paternoster is Professor at the Institute of Criminal Justice and Criminology, University of Maryland. In addition, he is conducting research on the legal ideologies of welfare workers and recipients.
