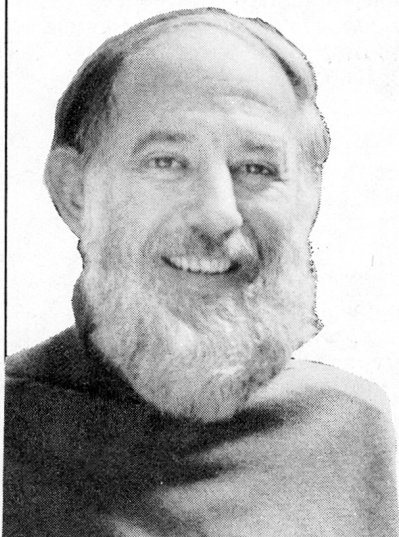

The concept of a viable tradition of Anglo-Irish literature is essentially a creation of the Revival period at the end of the nineteenth century, though the beginnings are evident some fifty years earlier. Developing out of that tradition—in different ways, of course—were some of the major writers of this century, as well as a great number of less familiar but nonetheless significant figures.

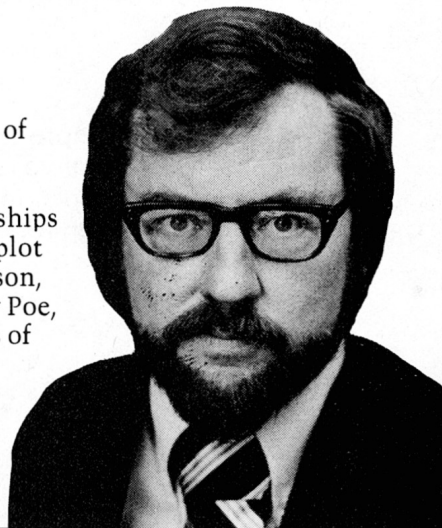

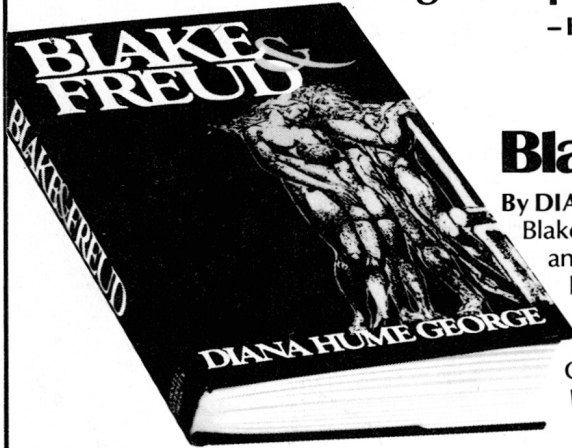
